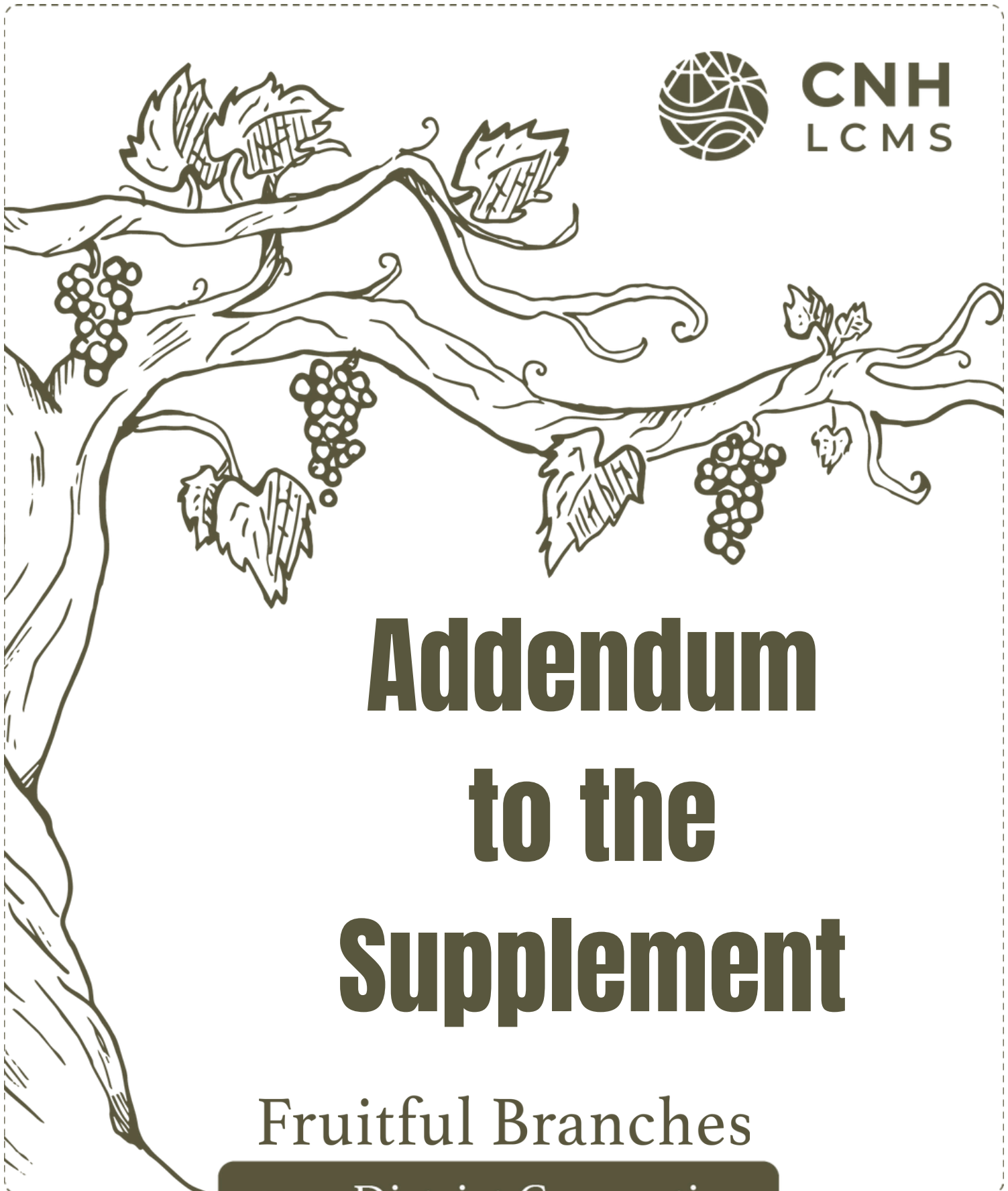

Update --- St. John's Lutheran Church of Petaluma, California -- St. John's Petaluma has been vacant since the end of 2021. Over the last several years St. John's Petaluma has attempted, with no success, to form dual-parishes or similar partnerships with neighboring congregations.

In the interim, and by the grace of our Lord, we have been blessed by the faithful service of Rev. Stuart Sultze of Faith Lutheran Church of Ukiah, CA. He graciously drives three hours, round trip, to serve us by leading our divine services and bible study several times a month. In addition, we gratefully receive monthly assistance from our circuit visitor and others. Though this has been a blessing, after considerable discussion and prayer, the congregation has decided it is best to call its own pastor and is currently in the process of interviewing candidates.
